l. Purpose:

We have been engaged by ANG LIFESCIENCES INDIA LIMITED having Registered office at SCO 113, Darbara Complex, First Floor, District Shopping Centre B Block, Ranjit Avenue, Amritsar, Punjab, 143001 for the purpose of valuation of equity shares of ANG LIFESCIENCES INDIA LIMITED ("ANG"/ "Company").

ANG is evaluating the fair market value of equity shares under preferential issue of shares under the provisions of SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018 (SEBI ICDR 2018). Since, the Articles of Association (AOA) of the Company prescribes that in case of further issue of shares, the Company is required to obtain a Valuation report from a Registered Valuer, therefore, ANG requires a Valuation of its shares for issuing shares in terms of the amended regulation 164 of SEBI ICDR 2018 and AOA of the Company.

Accordingly, as per the request received from the company, we are valuing the Equity Shares of the Company.

VIII. Approach Considered in our Value Analysis:

General Principle for Valuation

There is no single definition of the term 'Value' that is suitable for all purposes or at all times. The value of a particular asset may vary according to different valuation methodologies that are adopted to ascertain the value for a specific purpose. Valuation of securities is an inexact science. It may sometimes involve a set of judgments and assumptions that may be subject to certain uncertainties.



Broadly there are three approaches of Valuations which are as follows:

- a) "Net Asset Approach"
- b) "Profit Earning Capacity Value"- PECV approach
- c) "Market" Approach

IN SUMMARY:

The application of any method of valuation depends on the purpose for which the valuation exercise is performed; relevance of each method under the circumstances of the case and other factors as determined appropriate. The brief methodology in each of the three approaches as mentioned above is as mentioned hereunder:

- **Net Asset Approach:** This method takes into account the value of the assets of the business or the net worth as represented in the financial statements of the Company. For the purposes of arriving at net asset value per share, the net worth so arrived at shall be divided by the number of equity shares issued and paid-up.
- Profit Earning Capacity Value (PECV) Approach: This method of valuation presumes the
 continuity of the business and uses the past earnings to arrive at an estimate of future
 maintainable profits (FMP). For the purpose of the calculating PECV of shares, commonly
 accepted approach is to capitalize weighted average of past earnings, at an appropriate rate of
 capitalization, to arrive at the fair value per share.
- **Market Approach:** The market approach is a method of determining the value of shares based on the quoted price in the respective stock exchange where the shares have been listed.

Selection of Valuation Methodology

The objective of the valuation process is to make a best reasonable judgment of the value of the Equity Shares of the Company. The Company's Equity shares are presently listed on BSE and are frequently traded at BSE.

Further, Since, the Articles of Association (AOA) of the Company prescribes that in case of further issue of shares, the Company is required to obtain a Valuation report from a Registered Valuer.

Therefore, for the evaluation of fair valuation, we, being an independent Valuer, have considered best reasonable judgment to value the equity shares through average of Market Approach (the Closing price of the day immediately preceding the relevant date) and Net Asset Value. The Relevant date is 11th October, 2022.

We, being an Independent Valuer, have calculated Rs. 134.88 per equity shares as the fair value price of each Equity Share in accordance with Regulation 164 of the SEBI (ICDR) Regulations as per **Annexure** I.

Following is the summary of the Valuation:

Valuation & Conclusion:

In the ultimate analysis, valuation will have to involve the exercise of judicious discretion and judgment taking into account all the relevant factors.

The Fair Market Value per equity share of ANG as per above methodology is INR 134.88/- (Indian Rupees One Hundred Thirty Four and Eighty Eight Paisa).
